

Job Vacancy

Nam Theun 1 Power Company Limited (NT1PC) was authorized by the Government of the Lao People's Democratic Republic (GOL) to develop, own and operate the Nam Theun 1 Hydropower Project (NT1HPP). The Company has entered into a Concession Agreement (CA) with the GOL since 14 June 2016, the Concession period of which spans 27 years.

NT1PC is jointly owned by Four shareholders: Phonesack Group Company Limited (PSG), Chaleun Sekong Energy Co., Ltd. (CSE), Electricity Generating Public Company Limited (EGCO) and EDL-Generation Public Company (EDL-GEN).

The Project is located on the Nam Kading River in Bolikhamxay Province, approximately 33 km upstream of its confluence with the Mekong, and 220 km from Vientiane, central Laos. The Nam Theun River is one of the major tributaries of the Mekong River in Lao PDR, with a catchment area of 13,856 km² at the dam site.

NT1PC signed and entered into the Power Purchase Agreement with the Electricity Generating Authority of Thailand (EGAT) and the Électricité du Laos (EDL) The total installed capacity, with 3 generating units under 2 PPAs, is 650 MW, of which 2×260 MW will be supplied to EGAT and 130 MW to EDL for the duration of 27 years commencing from the Commercial Operation Date (COD) 12 August 2022.

Duty Description:

The ISO Supervisor is taking the responsibility to manage the overall duty of all ISO related aspects of the Project's work scopes. This position will provide support to the OHS & Risk Management Specialist by following responsibilities.

Responsibilities:

- Take the lead to compile all ISO related document for the whole NT1PC Project and submit to Document Control Unit for official documented information in monthly basis;
- Assist the Quality Management and Quality Environmental Representative (QMR/EMR) establishing a centralized ISO database system to improve and/or achieve the objective of the Quality Management and Environmental Management Systems;
- Coordinating between different department and section to effectively implement the ISO work requirement within the NT1PC Organization;
- Communicating and coordinating with ISO Audit Teams and ISO Consultant to resolve and improve ISO related aspect matters;
- Participate in internal and external audits to ensure compliance obligations are met.
- Provide support for the developing and maintaining the ISO requirement and process, and provide support to the ISO consultancy as required;
- Maintaining and updating company quality management system as instructed by management;
- Establishing standard ISO framework that NT1PC Organization could use to effectively implement the Environmental Management and Quality Management System following ISO 14001:2015 and ISO 9001:2015 standards.
- Monitoring and implementing the ISO requirement under ESMMP-OP guidelines to reflect CA, IFC and relevant applicable statutory and legal obligation.
- Train and supervise staff on Quality and Environmental Management assurance practices such as capacity training to minimize environmental adverse impacts;
- Perform other OHS related tasks as assigned by Line Management.
