



Job Vacancy

Nam Theun 1 Power Company Limited (NT1PC) was authorized by the Government of the Lao People's Democratic Republic (GOL) to develop, own and operate the Nam Theun 1 Hydropower Project (NT1HPP). The Company has entered into a Concession Agreement (CA) with the GOL since 14 June 2016, the Concession period of which spans 27 years.

NT1PC is jointly owned by Four shareholders: Phonesack Group Company Limited (PSG), Chaleun Sekong Energy Co., Ltd. (CSE), Electricity Generating Public Company Limited (EGCO) and EDL-Generation Public Company (EDL-GEN).

The Project is located on the Nam Kading River in Bolikhamxay Province, approximately 33 km upstream of its confluence with the Mekong, and 220 km from Vientiane, central Laos. The Nam Theun River is one of the major tributaries of the Mekong River in Lao PDR, with a catchment area of 13,856 km² at the dam site.

NT1PC signed and entered into the Power Purchase Agreement with the Electricity Generating Authority of Thailand (EGAT) and the Électricité du Laos (EDL) The total installed capacity, with 3 generating units under 2 PPAs, is 650 MW, of which 2×260 MW will be supplied to EGAT and 130 MW to EDL for the duration of 27 years commencing from the Commercial Operation Date (COD) 12 August 2022.

Duties Description:

This position will take a lead in managing and implementing of Livelihood Restoration Program (LRP) of Nam Theun 1 Power Company (NT1PC). He/she will be based at Viengthong District site office working closely with targeted communities and stakeholders to improve the livelihood of targeted production groups through agricultural best techniques applications and community participatory approaches:

Responsibilities:

- Lead and supervise livelihood team (cultivation and livestock officer) to implement the livelihood restoration program which covers on-farm activities such as cultivation, livestock and fisheries;
- Develop weekly, monthly quarterly and annual plans in order to implement program effectively and cohesively;
- Provide technical support to the motioning, evaluation and learning (MEL) mechanism and regular monitor and report of LRP implementation;
- Promote the application of sustainable, innovative and adaptive agriculture practices;
- Disseminate to the community to publicize the work, services and achievement of the best agricultural practices;
- Strategically engage stakeholders including PAPs and local authorities to enhance local leadership and ownership;
- Coordinate with relevant parties to prepare materiel sans suppliers to targeted groups in accordance with the LRP policy;
- Ensure the social inclusiveness of all PAPs in the development and implementation activities;
- Guarantee the effective and transparent utilization of resources;
- Assist any other tasks assigned by line manager or CSR director.

Requirements:

- Bachelor degree or higher diploma in agriculture, rural development or related field;
- At least 5 years' experience (for higher diploma) or at least 4 years' experience (for bachelor degree) demonstration work (farming - animal husbandry) with local and international projects;



- Technical experience and competency: agricultural techniques, agricultural principles such as home garden, organic vegetable, fruit tree, cash crops, livestock raising, and poultry – frog – catfish raising; animal feed processing and production of bio-fertilizer, micro-organisms - natural herbs, as well as proper storage and use methods; production calendar, business and marketing knowledge.
- Skills: communication skills, interpersonal skills, innovative thinking, social adaptation and resiliency, independent, team work, and leadership skills.
